JUDGES	<p>Only FIG brevetted judges, with the category I, II, III or IV (2017-2020) can judge.</p> <p>The participating Member Federations must send minimum one qualified Judge, as mentioned above. Failure to do so will result in a <u>fine of 250 EUR</u> - to be paid to the Organizing Member Federation.</p>																								





<p>ACCOMMODATION AND MEALS</p>	<p>The participating federations must pay for <u>Accommodation and Meals</u> (FB – full board) expenses of their delegation members. Book accommodation through the LOC is required.</p> <p>Four Stars Hotel</p> <p>Eur 95 (single room) Eur 80 (double room) Eur 70 (triple room)</p> <p>Three Stars Hotel</p> <p>Eur 90 (single room) Eur 75 (double room) Eur 65 (triple room)</p> <p>The prices charged for the hotel rooms will not exceed the usual hotel rates. While the Accommodation Form must be returned to the LOC by 8th of January at the very latest, the Hotel rooms will be allocated on a <u>“first come, first serve”</u> basis.</p> <p>The costs for the accommodations must be paid to the LOC as follows:</p> <ul style="list-style-type: none"> - 50% of the costs until the 8th of January 2018 - The final payment of the costs until the 8th of February 2018. <p>Cancellation/Reimbursement Policy: - <u>50%</u> of the costs with Accommodation in FB, shall be reimbursed if the cancellation <u>occurs up to 1 month prior to the event</u>. <p>DRAWING OF LOTS</p>	<p>The gymnasts and groups drawing of lots will take place at the Gymnastics Federation of Portugal within two weeks after the closing date of the nominative registration.</p>
<p>FINAL BANQUET</p>	<p>Tickets for the Final Banquet will be available for the cost of 30,00 € and must be paid at LOC office until March 9th 2018.</p> <p>The LOC will not reimburse any cancelled entry ticket of the Final Banquet.</p>





INTERNATIONAL TRANSPORTATION	<p>The invited participating federations and clubs must pay for the international travel expenses of their delegation members.</p> <p>The Travel Schedule Form must be returned to the LOC <u>until February 8th 2018</u>.</p>
LOCAL TRANSPORTATION	<p>The LOC will provide free local transportation for all participants (from/to Lisbon airport as well as from/to the hotel and the Competition, Training).</p> <p>Transfers and internal transportations will only be available to those who book accommodation directly with the organization.</p>
VISA	<p>Please verify with your local travel agent or the Portuguese Embassy or Consulate in your Country if a visa is required for your travel to Portugal.</p> <p>The LOC will be happy to assist each Delegation with an official invitation letter, provided that the request is made before January 8th 2018 to the LOC.</p> <p>The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.</p>
INSURANCE	<p>The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like.</p> <p>The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation.</p> <p>The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or copy of the valid policy). English version is compulsory.</p> <p>Delegation members with insufficient insurance cover must inform the LOC in advance. The LOC will subsequently offer insurance at the Federations own charge as follows: 35EUR per person/day.</p>
