<p><b>RIGHT OF PARTICIPATION</b></p>	<p><b>Individual Competitions (Junior &amp; Senior)</b></p> <p><u>Participation in the Qualifications:</u></p> <ul style="list-style-type: none"> <li>• All Individual gymnasts have to participate in the Qualifications.</li> </ul> <p><u>Participation in Finals:</u></p> <ul style="list-style-type: none"> <li>• The top eight (8, <u>Seniors</u> - 2 per Country) gymnasts and the top eight (8, <u>Juniors</u> – 2 per Country) gymnasts, per apparatus from the Qualification will participate in the Finals.</li> <li>• The participation in the Finals is limited to 2 gymnasts for juniors and 2 gymnasts for seniors, per Federation, per apparatus.</li> <li>• In addition, the Organising Member Federation may participate in the four finals with one gymnast, at its free choice. This <i>Wild Card</i> gymnast will have to start first.</li> </ul>
<p><b>INVITED CLUBS, ASSOCIATIONS AND FEDERATIONS</b></p>	<p>The participation is open to all Representatives of National Federations, District or Regional Associations as well as affiliated clubs in the respective Federations.</p> <p>All national teams, associations and clubs in good standing are entitled to participate, with unlimited gymnasts and groups.</p>
<p><b>SIZE OF DELEGATIONS AND LICENSES</b></p>	<p>Only gymnasts in good standing with the correct age and <u>holding a valid FIG License</u>, valid until the end of the event may participate.</p> <p>The Local Organizing Committee will be responsible for checking the validity of the gymnasts Licenses. No gymnast will be accepted without a valid FIG License at the time of the event.</p>

<b>AGE LIMITS</b>	<p>Juniors – Born in: 2003, 2004, 2005 Seniors – Born in: 2002 or before</p>																								
<b>JUDGES</b>	<p>Only FIG brevetted judges, with the category I, II, III or IV (2017-2020) with the respective brevet (RG I and/or RGG) can judge.</p> <p>The participating Member Federations must send minimum one qualified Judge, as mentioned above. Failure to do so will result in a <b>fine of 250 EUR</b> - to be paid to the Organizing Member Federation.</p>																								



<b>ACCOMMODATION AND MEALS</b>	<p>The invited participating federations must pay for <u>Accommodation and Meals</u> (FB – full board) expenses of their delegation members. Book accommodation through the LOC is required.</p> <p><b>Four Stars Hotel (per night/person)</b></p> <p>Eur 95 (single room) Eur 80 (double room) Eur 75 (triple room)</p> <p><b>Three Stars Hotel (per night/person)</b></p> <p>Eur 90 (single room) Eur 75 (double room) Eur 65 (triple room)</p> <p>The prices charged for the hotel rooms will not exceed the usual hotel rates. <b>DRAWING OF LOTS</b>	The gymnasts and groups drawing of lots will take place at the <b>Gymnastics Federation of Portugal</b> within two weeks after the closing date of the nominative registration.
<b>FINAL BANQUET</b>	Tickets to the Final Banquet will be available for the cost of <b>30,00 €</b> and must be paid at LOC office until <b>March 9<sup>th</sup> 2018</b> .  The LOC will not reimburse any cancelled entry ticket of the Final Banquet.
<b>INTERNATIONAL TRANSPORTATION</b>	The invited participating federations and clubs must pay for the international travel expenses of their delegation members. The Travel Schedule Form must be returned to the LOC until <b>February 8<sup>th</sup> 2018</b> .
<b>LOCAL TRANSPORTATION</b>	The LOC will provide free local transportation for all participants (from/to Lisbon airport as well as from/to the hotel and the Competition, Training). Transfers and internal transportations will only be available to those who book accommodation directly with the organization.
<b>VISA</b>	Please verify with your local travel agent or the <b>Portuguese Embassy or Consulate</b> in your Country if a visa is required for your travel to Portugal. The LOC will be happy to assist each Delegation with an official invitation letter, provided that the request is made before January 8 <sup>th</sup> 2018 to the LOC.  The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.
<b>INSURANCE</b>	The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like.  The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation.  The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or copy of the valid policy). English version is compulsory. Delegation members with insufficient insurance cover must inform the LOC in advance. The LOC will subsequently offer insurance at the Federations own charge as follows: <b>35EUR</b> per person/day.
<b>ACCREDITATION</b>	Accreditations will be given at the LOC office (Competition Venue) by schedule (made after receiving the flight plans), after the arrival of the Delegations. The FIG Gymnast License must be presented and checked upon accreditation.  <b><u>Gymnasts who do not present a valid FIG License are not allowed to compete.</u></b>  A <b>photo of each member of the delegation</b> (in electronic format – JPEG) <u>must be sent until the nominative registration (8<sup>th</sup> February 2018)</u> .
